**CONTRACT AGREEMENT**

THIS AGREEMENT, made this \_\_\_ day of NOV 06 2023, 2023 between the **APAYAO STATE COLLEGE**, with principal address at Malama, Conner, Apayao, represented by **DR. JOHN N. CABANSAG**, College President, herein called the "Procuring Entity" and **NISSAN COMMONWEALTH, INC.** represented by **MR. ANDREW FORD T. PALATAN**, Authorized Representative, hereinafter called "the Supplier", with office address at 41 Commonwealth Avenue Brgy. Holy Spirit, Quezon City, Metro Manila.

WHEREAS, the Entity invited Bids for certain goods and ancillary services, viz., **PROCUREMENT OF MOTOR VEHICLE (PASSENGER VAN) OF APAYAO STATE COLLEGE-LUNA CAMPUS** and has accepted the Bid by the supplier for the supply of those goods and services in the sum of **ONE MILLION FOUR HUNDRED NINETY-FIVE THOUSAND PESOS (PHP 1,495,000.00)** (hereinafter called "the Contract Price")

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
